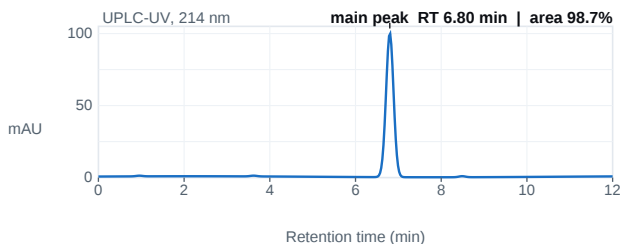


Fig. 1 — UPLC chromatogram; main peak 6.80 min, 98.7% area.

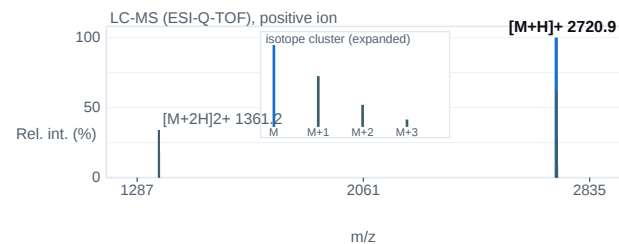


Fig. 2 — ESI-Q-TOF mass spectrum; base peak [M+H]<sup>+</sup> 2720.9 m/z.
